

## JUCY 5 Day Giveaway - Terms and Conditions

During the promotional period of 12:00PM AEST on 5 May 2026 to 11:59PM AEST on 25 May 2026 (**Competition Period**).

### 1. Promoter

The promoter is **JUCY Rentals**, a company incorporated in New Zealand.

### 2. Eligibility

The promotion is open to **legal residents of Australia & New Zealand** who are **18 years or older** at the time of entry. Employees of the promoter and their immediate families are not eligible to enter.

### 3. Promotion Period

The promotion opens at **12:00pm AEST on 5 May** and closes at **11:59pm AEST on 25 May** (the "Promotion Period").

### 4. How to Enter - No Purchase Necessary

No purchase is necessary to enter or win.

Eligible participants may enter by completing the online entry form via Facebook, Instagram or TikTok during the Promotion Period.

- a. Entrants may submit only one (1) entry in total, regardless of platform used.
